
A proposed new tournament to encourage the development of grassroots chess








Does your county organise an annual tournament, or series of tournaments, to determine a county women's champion?

What are the reasons you do not organise a tournament to determine a county women's champion?

Main categories of response:

- We haven't got any women players
- We never thought of it
- We can't find anyone to organise an Open event, let alone a Women's event





The ECF would like every county to have:

- A County Champion
- A Women's County Champion

We are hopeful that this tournament will:

- Encourage stronger players to participate in each County's Championship
- Encourage counties to increase their emphasis on encouraging women to take part in grassroots chess





The ECF understands that:

- Each county determines their County Championship in different ways:
 We are not going to tell counties how to run their own tournaments
- Each county has different eligibility rules to determine their County Champion: We are not going to tell counties which eligibility rules to use for their County Championship
- Not all County Champions will be "English": we do not seek to exclude them – or indeed, anybody – from participation in a County Championship





However, the ECF's requirements will be:

- In order to have a player who qualifies for the Champion of Champions, each county must have a tournament to determine a qualifier, rather than expect to nominate a player
- For the purpose of determining the Women's Champion, it can be the highest-placed female player in the main County Championship
- Counties will need to tell the ECF how their County
 Champion/Women's County Champion is determined so that we can track them and keep a calendar of events
- Ideally, the County Championship will be a tournament with qualified arbiters present, and FIDE-rated





- The tournament must generate <u>one</u> Champion only, at least to determine who qualifies to the Champion of Champions – you may need tie-breaks to determine the qualifier
- Players whose FIDE registration is RUS or BLR are not allowed to participate in ECF-organised events
- If the Champion cannot participate, the place cannot be passed down to another player – the tournament name is "Champion of Champions"
- It needs buy in from the counties it is no good the ECF putting on this tournament at some expense, and finding that nobody turns up!





The Champion of Champions Tournament:

- 5-round weekender at a hotel in the Midlands in Autumn 2026
- Open section and a Women's section
- Tournament will be FIDE-rated and ECF-rated
- To generate one winner, the tournament will have a Blitz playoff (if needed)

If a woman wins a County Championship, she may choose which tournament she plays in.





Prizes:

- All players who participate in at least 4 rounds of the tournament will receive a 1-year extension to their ECF Gold Membership.
- Better-than-normal prize money for a weekend congress
- A "keep-forever" trophy for the winner of each section
- Winner of each section gets free entry to their section of the English Championships (if eligible)
- Winner of each section qualifies for the British Championships
